Release and Waiver of Liability

Your flute should be insured with coverage that protects it coming, going, and while it is in my care. Please check with your insurance carrier to ascertain the scope of your coverage, before shipment. By signing this Release and Waiver, you irrevocably release and discharge Sarah Merrow and Syrinx Flute from any and all damages to your instrument and all other causes of action, claims, costs, and any other liability that arise from the **shipment and treatment** of your instrument while in transit and while in the care of Syrinx Flute. You agree to assume all risks with regard to your flute's shipment and treatment, and waive any liability as to Sarah Merrow and Syrinx Flute.

Optional

You may instruct Syrinx Flute to purchase shipping insurance on your behalf for shipment from Syrinx Flute to you, up to and including the value of the instrument, as declared by you below. You understand that Syrinx Flute will not purchase shipping insurance on your behalf unless you request it to do so in writing by filling out the form below. You understand that the cost of such coverage is determined by the carrier, and you agree to pay the cost of such coverage.

Claims

You agree that you are responsible for handling any claims that arise or are submitted as a result of the treatment and/or shipping of your instrument except as required by the shipping carrier. You agree to submit any such claims directly to the insurer. Syrinx Flute/Sarah Merrow has no responsibility for submitting or handling claims on your behalf, except to supply information as required.
